Mr. K. H. Patel is former Indian High Commissioner to Uganda and Ambassador to Rwanda and Burundi. Earlier, he was India's Consul General in France and a Diplomatic Officer at India's Permanent Mission to United Nations in New York, USA. He had served as a Member of the Indian Delegation to United Nations Tribunal on the Rann of Kutch Dispute between India and Pakistan at Geneva, Switzerland. He has also represented India at several international conferences including United Nations Human Rights Commission in Geneva and UNESCO General Assembly Session at sofia, Bulgaria.

As a Director of the Ministry of External Affairs, Govt. of India, in New Delhi, he handled a variety of foreign policy matters, including Pakistan. He visited about 40 countries in almost all parts of the world on official duty.

After retirement from the Central Government, he served as a Consultant of The Times of India Group, Mumbai, for a number of years. In this context, he helped bringing out 9 Special Supplements on African countries for The Economic Times. For this purpose, he visited countries such as South Africa, Zimbabwe, Ghana, Nigeria, Kenya, Tanzania and Uganda, etc.

He has served as Director on the Board of Directors of Government of Gujarat organization namely Non-Resident Gujaratis Foundation. For last four years he has been chairman of Gujarat Chamber of Commerce & Industry's Non-Resident Gujaratis (NRG) Centre which has been founded and maintained by Government of Gujarat.
