Considering the needs of skill development amongst the students enabling them for a successful career pathway in fast growing technology - intensive industry ecosystem, GTU has partnered with various leading industries partners like International Automobile Centre of Excellence (iACE - A Joint initiative of Govt. of Gujarat and Maruti Suzuki), TCSiON, L&T Edutech and Infosys Springboard to offer the "University Offered - Industry led Minor/Honor programs" to GTU students.

GTU has recently published the Policy of Minor/Hons. In terms of the guidelines on various aspects for the Institute offered Minor/Hons. Prorgam as well as University Offered-Industry lead Minor/Hons. Prorgam.

<u>General Instructions for students to opt for Industry Led minors/honors to GTU</u> <u>students:</u>

1. Duration of the University offered Industry led Minor/Hons.

During the academic span of Semester 4th to 7th and to the students of Semester 4th in AY 2024-25 having eligibility mentioned in the minor/hons. policy.

2. Eligibility:

Only the students pursuing Semester 4 in their current academic year (Sem 4 in AY 2024-25) are eligible to apply for the University offered, Industry led Minor/Hons. Students and faculties must go through the guidelines mentioned in policy for "University offered Industry-led Minor/Hons. Programs as well as the titles and subjects mentioned in the Annexures which are attached with the circular.

3. Execution of the program:

Nomenclature, Mode of operations, content delivery, periodic assessments, grading, certification and nomenclature of the subject in GTU transcript will be in line with the Comprehensive policy for "University offered Industry-led Minor/Hons. Programs'.

4. Registration Process & Deadline:

Students must complete the **registration and payment formalities by** $15/02/2025_{on}$ the respective course provider's portal through the link provided as per annexures with this circular and in case of any difficulty regarding registration and payments they may approach the concerned point of contact persons from respective course provider list as mentioned in the circular.

5. Assessment & Evaluation:

Assessment and evaluation for University Offered- Industry lead minor/Hons. Program shall be done by respective course providers as per their defined methodology and criteria.

Certification:

Students will receive a Certificate of Completion for a specific subject from course providers after successful completion of evaluation from respective course providers and in addition to this, GTU will provide Minor/Hons. Degree as per standard nomenclature prescribed in "University offered Industry-led Minor/Hons. Programs' guideline based on the student's eligibility of awarding Minor/Hons. as per fulfillment of required criteria.

6. Clarification regarding Course Fees, Refunds and Premature withdrawal from program:

6.1 Students opting for this program must register for each semester's wise subject/s

(i.e Semester 4, 5, 6 and 7 subjects) separately and will have to pay the course fee (subject wise fees) in each semester through the portal of the course provider.

6.2 As the subjects offered through the course providers contain financial obligations such as Course Fee and Assessment Fee, students need to strictly follow the registration & payment process with applicable terms and conditions defined by respective course providers. It is also advised that students go through all such terms and conditions as well as important guidelines carefully before the registration and payment.

6.3 GTU does not have financial obligations in any transactions happen between students and their respective course providers. Any matter pertaining to the same will be governed as per Comprehensive policy for "University offered Industry-led Minor/Hons. Programs'.

6.4 The student can withdraw from the minor/honors Subjects registered at any time. However, the refund of the fees shall be applicable as per Comprehensive policy for

"University offered Industry-led Minor/Hons. Programs and prevailing norms of course provider as per their policy and discretion.

7. Guidelines for Institutes:

7.1 Faculties should guide the students in selecting the most suitable subject/title as per the student's career inclination as well as the prerequisites.

7.2 Faculties should monitor students' progress, ensuring adherence to minor/hons. requirements in compliance with "University offered Industry-led Minor/Hons. Programs' guideline.

7.3 It is mandatory for students to update the institutional faculty mentor once he/she registered for minor/hons. with an industry course provider. So, the head of the institute will have to ensure the record keeping of all such students opted the industry-led minor/hons and provide the details in required format as and when asked by GTU on a timely basis.

7.4 Once the faculty coordinator receives details of all registered students, he/she will register the student against the applicable minor/hons. through an institute

Annexure I <u>Steps to register for Industry Led Minors/Honors</u> <u>(BE Semester 4 students, AY 2024-25)</u>

- **1.** Go through the list of Minors/Hons. Listed in the Annexures A to D below and review the list of companies providing Minor/Hons.
- 2. Review the most suitable title and company w.r.t your preferred technology and career pathway under the guidance of your institutional faculty and go through the detailed course contents of each subject on GTU Website (Go to Academics → Go to Minor/Hons. Prorgam Tab → Review the List of Minor/Hons. Titles → Click on Semester wise subject of relevant titles and review the syllabus). The same can also be accessed on the websites of course provides (IACE, &T Edutech, TCSiON and Infosys Springboard)
- 3. Once you decide about the title to enroll, register yourself on the website of the respective course provider by entering your basic details such as name, enrolment number, institute name and branch name and code and upon successful validation you will be redirected to payment page of industry partners (In case minors/hons. offered by industry is paid)
- IMP NOTE: For the course providers the students have to register and pay the fees subject-wise & semester-wise. The company may have shown all the courses (all subjects of semester 4,5,6 and 7) on their website with an option of registration for the course. So, it is strongly advised the students that they must register for the course (subject) as per the applicable semester only (based on the given annexure below/ syllabus on website of GTU) starting with Semester 4 subject/s in AY 2024-25 and onwards. There should not be any mismatch between the prescribed subject and the current semester of students.
- **4.** Download the receipt of payment (In case minors/hons. offered by industry is paid) /email confirmation of course registration.
- Provide the copy of payment receipt (Or the copy of the confirmation of the registration, where the Subject is free) to the HOD/Faculty coordinator of your institute.
