CIRCULAR

Important Circular for Special extension to the Students whose validity of enrolment number has expired

Reference: Approved minutes of academic council meeting dated 04th April 2017 & approved submission dated 22.05.2017.

GTU has decided to provide one more that is last chance to those students whose validity of the enrolment number has expired as per Notification No. 1 /2012 dated 13th April 2012. As per this notification there are (i) students who have kept all the terms but have backlog in subject(s) (including students to whom extension for one year for clearing the backlogs was given) (ii) students whose minimum two terms of the course are granted but not yet completed the study.

The details regarding each case along with the guidelines is given below:

Case I: For students who have kept all the terms but have backlog in subject(s) (including those students to whom extension for one year for clearing the backlogs was given)

The students whose all the terms are granted and only backlogs are left such students will be given 2 more chances that is (i) Winter 2017 examination and (ii) Summer 2018 examination for clearing the remaining subjects for all the courses and for all the components (that is E/I/M/V). No more chance will be provided in any circumstances to such students after completion of Summer 2018 examination.

Case II: For students (i) whose minimum two terms of the course are granted, (ii) are not detain as per GTU norms and (iii) not yet completed the study of remaining semester(s)

The students whose minimum two terms of the course are granted, <u>not detained</u> as per GTU circular No.Gtu/Evaluation/July10/4564 dated 29th July 2010 and not yet completed the study of remaining semester(s) will be given one more and last chance to complete their studies from the academic year 2017-18 onwards. Such students will be given chance to keep the term as per the remaining year(s) of study i.e. if a student has not cleared 2 semesters (1 year) he/she will be given 2 semesters (1 year) only for passing all the subjects of that course. No extra year(s) will be provided to pass the course. Complete bifurcation of all such students along with the time provided to them for completion of study & examination is given below:

- 2. The students who have only backlogs in the subjects will give examination as per the syllabus they have studied. No equivalent subject will be defined for the same.
- 3. The interested student will contact his/her institution. GTU has design an additional link on the admin panel (gtuexams.in) for registering such students of both the cases. Institute will have to register all such students who have applied for special extension

as per the process defined in the 'Term Extension 2017'file attached herewith as Annexure I.

- 4. Registration of such students will be open for 2 months (that is 60 days) only. All the students have to compulsory register during these 2 months only, even though they may become regular in even semester for case 2 (that is from even semester of academic year 2017-18). Last day of registration will be 04.08.2017 for this special extension.
- 5. The students who will be detained or caught in unfair means in this special extension period will not be given any more extension.
- 6. The students who have enrolled with GTU and their 2 terms have not been granted i.e. 1st and 2nd Semesters terms are not granted are not eligible for the extension.
- 7. Rs 1500 (One thousand five hundred only) as fees for this special extension will be paid by students who desires to register.
- 8. The students who will commence his/ her regular studies in even semester will be eligible for remedial examination of backlog(s) during Summer 2018 examination.
- 9. No students whose validity of the enrolment number has not yet expired as per Notification No. 1/2012 can cite this special extension arrangement as a precedence and ask for extension whenever it is due to him/her, in future.
- 10. Affiliated institutes will have to make all arrangements to communicate this special extension arrangement to all such students.
