GTU is announcing its International Experience Program (IEP) for the 6<sup>th</sup> consecutive year as a part of its continuous journey towards becoming a truly global university. Under IEP, since 2011, GTU is sending students to Germany, USA, Russia and Canada in the months of June and July every year. In 2016, MBA & B.E (Electrical Engineering) were organized Wismar University, Germany. This year along with MBA one new branch i.e. B.E (Automobile Engineering) is introduced at Wismar University, Germany.

GTU is inviting application from interested students for IEP -2017 at Wismar University, GERMANY. Please go through the information given below.

At Wismar University, GERMANY, the classes for these subjects will be held regularly for at least 4 weeks during the summer. The students have to appear in the midterm and final exam for the above courses at Wismar University, GERMANY. Once student successfully studies the course and finishes all the required assessment at Wismar University, GERMANY, he/she will be back to his/her Parent College and finish their remaining subjects of the final year.

Upon successfully passing the exams at Wismar University, GERMANY, a student may be given subject waiver for the above mentioned subjects accordingly. A student, who passes the examinations for both the courses successfully at , will be able to take two less subjects during the final year and will not have to retake these courses when he/she resumes his/her study back at his/her parent college. The institute may conduct extra classes/ lectures/ guidance sessions if required or requested by the students participated in IEP.

GTU will get VISA related papers from Wismar University, GERMANY for the selected students and then the students will be guided to apply for the VISA.

**Please note** that short listing does not guarantee the visa for a student, since every student has to fill up the visa application form and supply the necessary information to the Embassy in India.

**Classes at Wismar University, GERMANY for the IEP will start during the second week of June 2017.**

**A detailed time table and exact dates will be made available to the selected students.**

## Selection Criteria

### 1. Basic Criteria:

- Students who are going to appear in the university exam of semester-6, BE(Automobile Engineering) Students in summer-2017 can apply for the program.

### 2. Academic Criteria:

- Applicant's CPI/CGPA must be 4.0 and above till semester-5 for BE(Automobile Engineering) Students.
- Total backlog should not be more than 3 at the time of application.

On basis of above mentioned criteria, students will be selected to pay the confirmation fees on first come first serve basis according to their application date and time due to availability of limited seats.

- **Please note: The visa fees is nonrefundable in case of non-granting of the visa or once it is paid to High Commission.**
